


# NOTICE OF COMPLETION

## Marter Twp. Waterpower Project – Blanche River



**February 10<sup>th</sup>, 2014** - Xeneca Power Development Inc. ("Xeneca") is proposing to build a modified run-of-river hydroelectric generating station (Marter Twp. GS) with a total installed capacity of 2.1 MW. The project will be located on the Blanche River 9 km north of the Town of Englehart. The project is subject to provincial environmental assessment requirements under the *Environmental Assessment Act*. An Environmental Report ("ER") has been prepared as required under the Class Environmental Assessment for Waterpower Projects (Class EA.) The ER concludes that there are no significant adverse effects after the application of mitigation and adaptive management measures. The Marter Twp. GS is categorized as a project on a managed waterway pursuant to the Class EA.

It is expected that Xeneca will meet the intent of water management planning through the EA process and MNR's subsequent review and approval of the project under the Lakes and Rivers Improvement Act (LRIA.)

In compliance with the Class EA, the ER will be available for a thirty three-calendar day review period from February 10 through to March 14, 2014. Xeneca must receive all comments in writing regarding the proposed project and/or the ER no later than 11:59 pm on March 14, 2014.

In the event that issues cannot be resolved during the review period, the concerned party may make a written request to the Minister of the Environment at the address noted below for a Part II Order under the Environmental Assessment Act (Individual Environmental Assessment.)
